Your package should provide answers to the following questions: Clearly express what your project is about (synopsis, story, themes)? Tell us what stage is it at? Are there any attachments that we need to be aware of, such as did you write this to star in the film or do you have to direct it? If yes, what is the track record and previous work of the attachments? Why do you want to tell this story? Why a motion picture vs. a book or an article or a documentary? These answers need to come from the storyteller, i.e. writer/director or creative producer. Characterize the audience you are aiming to impress? Provide a description of your story's main characters. Do you have any casting ideas at this stage and how do you plan to approach that cast? When and where are you hoping to make this film? List all primary locations and not how much of the story takes place in that location.

The submission of the material to BoomGen Studios (BoomGen) requires that the copyright owner (Owner) agrees to and acknowledges the following conditions:

1. The Owner agrees that any part of the submitted material that is not novel or original and not legally protected may be used by BoomGen without any liability on BoomGen's part to the Owner, and that nothing herein shall place BoomGen in any different position with respect to such non-novel or non-original material by reason hereof.
4. BoomGen is not under any obligation to pay the Owner with respect to the submitted material unless later set forth in a fully executed written agreement.
5. The Owner realizes that BoomGen may have had access to and/or may have independently created or have had created ideas, themes, formats and/or other materials which may be similar to the theme, plot, idea, format or other element of the material now being submitted by the Owner, and the Owner agrees that he/she will not be entitled to any compensation by reason of BoomGen's use of such similar material.
6. BoomGen is under no obligation to review or keep the submitted material. The Owner should at all times retain a copy of the submitted material.
